

# 5<sup>th</sup> ANNUAL EASTERN NAVAJO ARTS & CRAFTS FESTIVAL

## VENDOR REGISTRATION FORM

### Festival Rules:

- No alcoholic beverages or illegal substances are permitted at the festival.
- All arts and crafts displayed for sale must be original work and stamped by vendor from an Eastern Navajo Chapter.
- To all silversmith jewelers, jewelry should be stamped sterling silver. No nickel silver or silver-plated jewelry. (Jewelry will be inspected)
- Food and Beverage vendors must also be from Eastern Navajo Chapter and display a Navajo Food Handlers & Selling permit.
- Vending areas for food and beverages will be separated from vending areas for arts & crafts.
- Each booth must fit within a space 10' wide and 8' deep. (Space will be reserved on a first come, first-served basis in the order in which registrations are received).
- Vendors must register and pay in advance by cash or money order, payable to: Eastern Navajo Arts & Craft Festival. Sorry, no personal checks will be accepted.
- Until Thursday, June 26<sup>th</sup>, the registration fee for booth will be **\$35.00 OR \$50.00 after June 26<sup>th</sup> 2008.**
- Vendors create and equip their own booths; set up begins at 7:30 a.m.
- Each vendor is solely responsible for the safety of his or her equipment and supplies during the festival.
- Due to a limited space, vendors must unload before the event begins and park at the designated areas. Vehicles will not be permitted inside the premises once the activities begin.
- No refunds on cancellations.
